#### **Links Continued**

- Markets BIDC to concentrate on export access of products and services. Ability to access other SBDCs in North America, Latin America and the Caribbean for imports and exports through MOUs and SBDCGlobal.com.
- Supports YES to concentrate on youth entrepreneurship. UWI (Cave Hill) to facilitate business development research and student support services for businesses. Fund Access to provide financing for businesses. SBDCs have the ability to form alliances with quality support professionals such as accountants and government and non government organizations.
