Main Points


- Governments in the region need to clearly define what is meant in policy terms by 'Entrepreneurship' and the **primary** goal of public policy in supporting its development
- 2. Need to address the main constraints to enterprise development, including the issue of accessing affordable finance, and the promotion of 'internationalisation'

1. Entrepreneurship in Caribbean Policy

- O In Caribbean public policy:
 - 'Entrepreneurship' = Selfemployment
 - Policy goals are broad and diverse:
 - Poverty alleviation
 - O Empowerment
 - Enhanced quality of life
 - Enhanced productivity
 - Increased economic growth
 - Foreign exchange generation


- Such broad goals make it difficult to implement strategies to meet all objectives with a fiscal constraint- focus is needed
- Strategy with PRIMARY GOAL to promote foreign exchange generation will be different to one seeking to alleviate poverty

...... Employers ---- Own-Account Workers ---- TOTAL SELF-EMPLOYMENT ----- Lagged GDP Growth (†-1)



2. Constraints to Entrepreneurship's Contribution

1. Access to finance


2. Domestic focus and a lack of entrepreneurial orientation

In CARICOM access to finance is a major constraint...



Access to Finance- Major Constraint (Average of surveys since 2005) (%)

In Barbados, commercial bank finance increasingly directed to Consumer Credit...



Lack of 'true' entrepreneurial orientation with a domestic market focus...

Exporting Activity

- 92.8% of firms main market is domestic, with 18.8% undertaking some level of exporting
- For exporting firms, exports account for 41.1% of sales
- Destinations mainly other CARICOM countries, followed by USA and Europe
- Exporters more likely to have some foreign ownership

Potential Causes of Domestic Focus

- "Satisficer" attitude
- Fear (risk aversion)
- Lack of knowledge of internationalisation modes
- Non-niche product choice and high levels of domestic competition
- Government policy that focusses on 'wooing and fawning' foreign investors and generating low value-added self-employment

Creating a Entrepreneurial-driven Economy

- Determine PRIMARY policy goal for an entrepreneurial development policy
- Introduce compulsory entrepreneurial education programmes in secondary schools
- Implement widespread training and sensitisation in internationalisation modes
- Develop proactive rather than reactive business support

- Encourage product development in high valueadded activities
- Develop comprehensive credit bureau systems (reduces risk of lending and cost of borrowing)
- Develop comprehensive financing system for MSMEs (equity and debt)
