INTRODUCTION

The Economic Commission for Latin America and the Caribbean (ECLAC) and the Permanent Secretariat of the Latin American and Caribbean Economic System (SELA) share the interest in supporting regional integration processes as relevant mechanisms for the economic and political development of Latin America and the Caribbean. The Permanent Secretariat of SELA and ECLAC have promoted research to increase knowledge about the advances made in different subregional integration mechanisms in various fields of interest to the region. Therefore, they are organizing a seminar for reflection and discussion on the future of integration processes in Latin America and the Caribbean.

In the "Seminar: Prospective vision of Latin American and Caribbean integration", both institutions will present the main results of some research studies on the status of integration processes, as well as the main challenges and opportunities for the region. In 2016, SELA worked on the design of an integration index for Latin America and the Caribbean (INTALC) to measure the degree of integration of the countries in the region and monitor its evolution. New topics were incorporated into this index with the inclusion of dimensions that are not traditional in this type of indicators, such as social, migration, labour and cultural matters. Furthermore, ECLAC has worked on various documents related to regional integration, including the analysis of intra-regional trade, its typology according to its technological contents and regional value added.

This seminar aims to discuss the status and future of integration processes in Latin America and the Caribbean. To that end, participants will be able to analyse recent studies on integration schemes and challenges posed by the international environment, intra-regional trade and future scenarios, with the participation of experts in the various integration mechanisms, as well as international organizations.

The event will feature round tables on regional and subregional integration schemes that contribute to the strengthening of integrationist ties of the countries in the region. The contents of this activity are based on the following four topics: regional and subregional integration mechanisms and organizations; SELA's follow-up report on integration mechanisms; tools for monitoring, analyzing and measuring regional integration; challenges posed by the international environment; and prospects for Latin American and Caribbean integration processes.

1. REGIONAL AND SUBREGIONAL INTEGRATION MECHANISMS

The first session will focus on the analysis of the different subregional integration mechanisms from the view of a representative of each mechanism. In fact, this session will offer an overview of the integration mechanisms and delve into the status of the integration schemes individually and the evolution of their member countries in their efforts to fulfil their objectives. Representatives of the Caribbean Community (CARICOM), the Secretariat for the Central American Economic Integration (SIECA), the Andean Community (CAN), the Common Market of the South (MERCOSUR) and the Pacific Alliance (AP) are expected to attend the seminar.

2. REGIONAL ORGANIZATIONS THAT SUPPORT INTEGRATION

This session will focus on the discussion of the role of integration organizations whose main purpose is to promote and boost integration and cooperation among the countries in the region. In this connection, representatives of different organizations, such as ALADI, SEGIB, ECLAC and

SELA, will make a brief presentation of the evolution of their work through the collaboration with countries and other institutions to promote regional integration.

SELA will offer a brief overview on the status of the integration mechanisms through the presentation of the Report on subregional integration mechanisms.

3. MEASURING REGIONAL INTEGRATION

The third session deals with some ways of measuring regional integration in Latin America and the Caribbean (LAC) and other regions of the world with similar integration processes. Participants will discuss how regional asymmetries and convergence are conceived on the basis of the results obtained in studies that aim to standardize the fundamentals of measurement within the conceptual framework of integration.

Emphasis will be made on a tool for measuring integration in LAC (INTALC), which offers the possibility of quantitatively evaluating the degree and the stage of the integration process in which every integration mechanism under review stands. It is used to analyze regular events within the economic situation of countries, following up on the integration mechanisms and assessing their status. Case studies put forward different experiences submitted by both regional and extraregional blocs, which draw useful lessons for the countries in the region.

4. THE INTERNATIONAL ENVIRONMENT AND THE CHALLENGES OF INTEGRATION

The globalization process and the multilateral system built after World War II have reached a new stage in which noticeable wear of the global regulatory system and institutions created around it is observed. While international trade, economic integration processes and the resulting globalization have created wealth and productive efficiency, costs for groups or countries lagging behind have emerged and an unprecedented concentration of wealth is evident. At present, options for policy and rapprochement in international relations have arisen, questioning values such as cooperation, primacy of the multilateral system, and respect for the set of global standards and conventions in the field of trade and investment, environment, among others. Integration processes should consider their future, the validity of their assumptions and how to upgrade their development proposals.

5. PROSPECTS AND LONG-TERM VISION OF INTEGRATION

As a result of the analysis of asymmetries, the integration index and the evaluation of convergence, the Permanent Secretariat proposed the creation of a tool to generate reference scenarios on medium- and long-term prospects for the different integration schemes.

In addition, cooperation actions of ECLAC with different regional integration mechanisms and organizations provide information on the integration agenda in the future, as well as its main objectives.
